Statement on Governor's Budget Proposals Related to Victim Services & Domestic Violence

Glastonbury, CT – Meghan Scanlon, President & CEO of the Connecticut Coalition Against Domestic Violence (CCADV), today released the following statement regarding Governor Lamont's biennial budget proposal which includes \$13.175 million allocated from pandemic relief funds in Fiscal Year 2024 to replace lost federal funding from the federal Victims of Crime Act (VOCA). Said Scanlon:

"We thank Governor Lamont for stepping up again this year to help keep victim service organizations in Connecticut whole in the face of declining federal funding. A portion of the Governor's proposed allocation will help ensure that CCADV and our 18 member organizations can continue to provide life-saving services to the nearly 40,000 survivors of domestic violence who walk through our doors each year. Filling the federal funding gap will help support crisis response, court-based advocacy, coordination with law enforcement, and advocacy related to the basic needs of victims, all critical services as the state continues to grapple with a string of horrific domestic violence homicides. We applaud Governor Lamont for his continued leadership in supporting victim service organizations and all of those whom we serve."
