## **RAPID RE-HOUSING**

HOUSING IDENTIFICATION | RENTAL ASSISTANCE | CASE MANAGEMENT

### **PROGRAM OVERVIEW**

In collaboration with HUD and the Connecticut State Department of Housing, CCADV oversees multiple federally funded tenant-based rental assistance programs throughout the state. Partnering with 24 nonprofit organizations, CCADV ensures these programs are accessible across Connecticut. These initiatives help individuals and families secure and maintain safe, permanent, and affordable housing. Flexible financial assistance is available to expedite the process of moving tenants into housing. The amount of rental assistance varies per household and adjusts over time. Each household is assigned an advocate who acts as the landlord's point of contact and provides ongoing support to help maintain long-term housing stability.

MONTH 1Program pays 100% of security deposit / first month's rentMONTH 2 - 6Tenant pays 30% of income, program pays the differenceMONTH 7- EXITTenant pays 60% of income, program pays the difference\*Number of months in program varies per household

### LANDLORD BENEFITS

- Access to a pool of ready-to-rent tenants.
- Guaranteed the full security deposit (up to two-month's rent), full first month's rent, and on a case-by-case basis the program may be able to help with last month's rent and damages to the unit.
- Tenants may receive time-limited subsidies which allows time to stabilize, build an emergency fund, and stay in good standing with rental payments.
- A point of contact. Case managers work with tenants on an ongoing basis to make sure they have the support they need to succeed. Supports include regular home visits, job readiness/job search, landlord mediation, and budgeting.
- Quick payments. Landlords can sign up to receive payments directly into their bank account.

Everyone deserves a safe and affordable place to live. By participating, you are playing an important role by helping households sustain housing and also by making your community a better place to live. Since the programs began in 2019, landlords have partnered with us to house over 500 households.
